#### **Bluetooth Connection**

- 1. Install Graphical Analysis 4 on your computer, Chromebook<sup>TM</sup>, or mobile device. If using LabQuest 2, make sure LabQuest App is up to date. See www.vernier.com/ga4 for Graphical Analysis 4 availability or www.vernier.com/downloads to update LabQuest App.
- 2. Charge your sensor for at least 2 hours before first use.

#### **USB** Connection

- 1. If using a computer or Chromebook, install Graphical Analysis 4. If using LabQuest 2, make sure LabQuest App is up to date. See www.vernier.com/ga4 for Graphical Analysis 4 availability or www.vernier.com/downloads to update LabQuest App.
- 2. Connect the sensor to the USB port.

- 3. Turn on your sensor by pressing the 3. Launch Graphical Analysis 4 or power button once. The LED will blink red.
- 4. Launch Graphical Analysis 4 or turn on LabQuest 2.
- 5. If using Graphical Analysis 4, click or tap Sensor Data Collection. If using LabQuest 2, choose Wireless Device Setup > Go Direct from the Sensors menu.
- 6. Select your Go Direct sensor from the list of Discovered Wireless Devices. Your sensor's ID is located near the barcode on the sensor. The LED will blink green when it is successfully connected.
- 7. Click or tap Done. You are now ready to collect data.

# **Charging the Sensor**

Connect Go Direct Acceleration to the included Micro USB Cable and any USB device for two hours.

You can also charge up to eight Go Direct Acceleration Sensors using our Go Direct<sup>TM</sup> Charge Station, sold separately (order code: GDX-CRG). An LED on each Go Direct Acceleration indicates charging status.

Charging	Orange LED next to battery icon is solid while sensor is charging.
Fully charged	Green LED next to battery icon solid when sensor is fully charged.

# **Powering the Sensor**

Turning on the sensor	Press button once. Red LED indicator next to Bluetooth icon flashes when unit is on.
Putting the sensor in sleep mode	Press and hold button for more than three seconds to put into sleep mode. Red LED indicator stops flashing when sleeping.

# **Identifying the Sensor**

When two or more sensors are connected, the sensors can be identified by tapping or clicking Identify in Sensor Information.

# **Using the Product**

Connect the sensor following the steps in the Getting Started section of the user manual.

#### Channels

Go Direct Acceleration has 11 measurement channels:

- X-axis acceleration (m/s<sup>2</sup>)
- Y-axis acceleration (m/s<sup>2</sup>)
- Z-axis acceleration (m/s<sup>2</sup>)
- X-axis acceleration high (m/s<sup>2</sup>)
- Y-axis acceleration high (m/s<sup>2</sup>)
- Z-axis acceleration high (m/s²)
- X-axis gyro (rad/s)

- Y-axis gyro (rad/s)
- Z-axis gyro (rad/s)
- Altitude (m)
- Angle (°)

### Acceleration

There are six acceleration channels, measured by two different chips, which are located under the 3-axis icon on the sensor label. The icon shows the positive direction for each axis, with the x-direction of acceleration parallel to the length of the sensor and the z-direction straight up through the label. Each direction of acceleration can be measured separately.

If you choose to activate three acceleration channels from one chip at once, you can create a calculated column for the total acceleration magnitude.

### Gyroscope

Use the gyroscope channels to measure the rotation rate of the unit. Measured values are positive when the rotation is counter-clockwise relative to the axis directions indicated by the 3-axis icon on the label. For example, when placed label upward on a turntable rotating clockwise, the x- and y- gyroscopes will read close to zero and the z- gyroscope will show a negative reading.

If you choose to activate all three gyroscope channels at once, you can create a calculated column for the total magnitude of angular velocity.

#### Altitude

The altimeter channel measures altitude with a range of -1800 m to 10,000 m. Zero the altimeter before use to measure relative height above and below your zero level.

### Angle

The angle measurement channel uses the  $\pm 16~g$  accelerometer chip and trigonometry to calculate the angle of the x-direction axis relative to horizontal. If you set the sensor flat on a horizontal surface with the Angle channel turned on, the green "level" LED,  $\diamondsuit$ , will glow to indicate  $0^{\circ}$  (horizontal) or  $90^{\circ}$  (vertical) inclination.

# Calibrating the Sensor

#### Acceleration

In most cases, calibration is not necessary for this sensor. However, most accelerometers, including this one, sense gravity as well as acceleration. Thus, if you want to measure vertical acceleration separate from gravity, simply place the sensor in its measurement orientation and zero the axis that is pointing vertically upward.

If you plan to use this sensor exclusively for vertical acceleration, it makes sense to calibrate the sensor so that zeroing will not be necessary every time a new

experiment is created in the software. Calibration writes an offset value to the sensor, as opposed to setting a zero temporarily for the duration of an experiment. The offset value will then be applied each subsequent time the sensor is used. To calibrate the sensor, click or tap the meter for the axis you wish to offset and choose Calibrate. Orient your sensor as for measurement and enter 0 m/s² (or whatever offset you choose, for example –19.6 m/s² if you orient an axis vertically downward instead of upward). Click or tap Keep, then Apply the calibration.

### Gyroscope

This sensor is factory calibrated.

#### **Altitude**

This sensor is factory calibrated, but you can choose to offset the value based on your physical location using the calibrate option.

## Angle

This sensor is factory calibrated.

### **Care and Maintenance**

# **Battery Information**

Go Direct Acceleration contains a small lithium-ion battery. The system is designed to consume very little power and not put heavy demands on the

battery. Although the battery is warranted for one year, the expected battery life should be several years. Replacement batteries are available from Vernier (order code: GDX-BAT-300).

### **Storage and Maintenance**

To store Go Direct Acceleration for extended periods of time, put the device in sleep mode by holding the button down for at least three seconds. The red LED will stop flashing to show that the unit is in sleep mode. Over several months, the battery will discharge but will not be damaged. After such storage, charge the device for a few hours, and the unit will be ready to go.

Exposing the battery to temperatures over 35°C (95°F) will reduce its lifespan. If possible, store the device in an area that is not exposed to temperature extremes.

#### Water Resistance

Go Direct Acceleration is not water resistant and should never be immersed in water.

If water gets into the device, immediately power the unit down (press and hold the power button for more than three seconds). Disconnect the sensor and charging cable, and remove the battery. Allow the device to dry thoroughly before attempting to use the device again. Do not attempt to dry using an external heat source.

### How the Sensor Works

#### Accelerometer

The accelerometers are microelectromechanical devices (MEMS devices) each consisting of a cantilever and a test mass. As the mass is accelerated, the cantilever bends, generating a signal proportional to the acceleration. Three orthogonal axes provide three channels of acceleration information for most experiments and an additional three channels of acceleration for high-g situations are also available. Acceleration measurements are used for the angle measurement.

### Gyroscope

The gyroscope is a microelectromechanical device that uses a vibrating structure to determine rate of rotation using the Coriolis force on the structure. Three orthogonal axes provide three different channels of rotation information.

### **Altitude**

The altimeter is a temperature-compensated, absolute air pressure sensor that can measure from 260 mBar up to 1260 mBar. We use the following equation to convert to altitude in meters:

$$ext{altitude} = 44330 igg(1 - igg(rac{p}{p_0}igg)^{rac{1}{5.255}}igg)$$

assuming that  $p_0$ , the pressure at sea level, is 1013.25 mBar. The resulting altitude range is from about -1800 m to 10000 m.

The absolute pressure accuracy is  $\pm 0.2$  mBar which can give you an error of  $\pm 1.4$  m to  $\pm 5$  m depending on which end of the scale you are at (-1800 m or 10000 m respectively).

You will often want to study the change in altitude during an experiment. Examples would include roller coaster rides, sky dives, or bungee jumps. In these cases, the absolute altitude above sea level is not as important as relative altitude compared to the ground or to the starting point of data collection. Zero the sensor before collecting data to use relative altitude.

### **Additional Information about Acceleration**

Since the accelerometer is sensitive to both acceleration and the Earth's gravitational field, interpreting accelerometer measurements is complex. A useful model for understanding accelerometer measurements is a spring-based scale with a reference mass (or object) attached to the scale. If the scale is pointing upward (the usual orientation for such a device) the weight of the mass causes the spring to compress, and you get a non-zero reading. If you were to turn the scale upside down, the spring will be extended, instead of compressed, and we get a reading of the opposite sign. If you turn the scale so it points sideways, and keep it motionless, then the spring will just be at its relaxed length, and the reading will be zero. If you accelerated the scale toward the mass, then the spring would compress. If you accelerate the scale away from the mass the spring would stretch. In each case the scale is reading a value corresponding to the normal force on the mass. This reading can be made relative by dividing out the mass, giving units of N/kg, which is the same as m/s².

### Q: What does an accelerometer measure?

A: It meaures normal force per unit mass, otherwise known as proper acceleration.

Note that it's not the net force per unit mass (which is acceleration), but it is the normal force per unit mass. This somewhat unusual quantity corresponds with what a rider on a roller coaster feels during the turns. This interpretation is useful even for the scalar total acceleration value, which is 9.8 N/kg for a 3-axis accelerometer at rest, zero for one in free fall, and greater than 9.8 for one rounding a corner.

This normal force interpretation works even for a one-axis accelerometer being accelerated in a horizontal direction. The reading is non-zero as the test mass inside the device has to have a force applied to accelerate it. That's just a normal force that happens to be horizontal.

When discussing the accelerometer reading, we can call it the Normal Force per Unit Mass, with units of N/kg.

### Q: I thought the accelerometer measured acceleration!

A: Here we are being very careful to not call something an acceleration when it is not a kinematic acceleration. For example, an "acceleration" of 9.8 m/s² for an object that remains at rest is clearly a problematic interpretation, yet that's what the accelerometer reads.

You can correct the accelerometer reading to get a true acceleration by adding the component of the gravitational acceleration field along the direction of the sensor arrow. For example, if the axis of the accelerometer is pointing upward, then the gravitational component is  $-9.8 \text{ m/s}^2$ . The accelerometer reads  $9.8 \text{ m/s}^2$  when the arrow is upward and the device is at rest. By adding  $-9.8 \text{ m/s}^2$ , we get zero, which is the correct acceleration. If the arrow is horizontal, then the reading is zero, but the gravitational component is zero, and we still have zero for the true acceleration.

### Q: What about *g*-force measurements?

A: We avoid the term *g*-force because the quantity doesn't have units of force. Instead, *g*-factor can be used as a simplified label for Normal Force per Unit Mass in axis labels and discussions.

You can see that the *g*-factor is then 1 for an object sitting at rest on a table, zero in free fall, etc. The *g*-factor is dimensionless. If the Normal Force is a vector, then so is the *g*-factor. *g*-factor is completely optional—it is just a shortcut to avoid a long name.
